These conditions apply to the contribution of logis as well as to the hiring from conference and flank areas to the execution of meetings to all with these coherent further supplies and achievements. They apply in the same way to the hiring of other areas, showcases and surfaces within meeting ranges connected with the hotel.

The following trading conditions apply excluding. Trading conditions of the Guest (uniform name for the organizer / orderer / guest etc.) become, even if these not expressly contradicted became, not subject-matter of the contract.

1. Contractual relation

The reservation of areas and surfaces as well as the agreement of other supplies and achievements become binding with the confirmation of the hotel for both parties or, if this is no longer possible for time reasons, with the supply. The reservation of areas, showcases and surfaces justifies a renting relationship. One

Under or subletting as well as a use from hotel rooms to others than living purposes need that written agreement of the hotel.

If the reservation is made by third, then also this becomes, regardless of one and is responsible itself to effective agency by the guest, contracting party for all commitments beside the guest, resulted in from the present Treaty, as a total debtor.

2. On and departure

Booked rooms are to the guest with journey starting from 14.00 o'clock and on the departure day to 11,00 o'clock at the disposal. The regulation that the guest which can be assigned area takes place on the journey day via the hotel.

If not expressly a later was arrival time-agreed upon, the hotel has the right, booked To assign room in accordance with 18.00 o'clock otherwise, without the guest from this claims deduce

can. To that extent a return of the contract is entitled to the hotel. The guest is asked, with an intended

To communicate departure for 11.00 o'clock the receipt this at the latest to 18,00 o'clock the day before the departure.

3. Prices

The prices determine themselves according to that at the time the achievement contribution valid price list.

As far as legal value added tax results, it is enclosed in the prices. An increase of the value added tax after conclusion of a contract goes debited to the guest.

, then the hotel the right reserves itself four months to make an appropriate price adjustment.

4. Terms of payment

All calculations of the hotel due to the present Treaty are due within 14 days starting from invoice date without departure of the payment. In each case the hotel can require a pre-payment in appropriate height of the guest. During excess of aforementioned time fixed for payment the guest comes into delay, without it requires a reminder. Starting from distortion entrance the hotel is justified to require interests at a value of 4% over the respective rate of discount of the German Federal Bank. The asserting of a higher distortion damage remains of it unaffected.

For reminders, which take place after distortion entrance, a small fine can be required by euro 10.00 in each individual case.

5. Resignation and cancellation

In case of higher force or other causes of impediment, in particular such outside of the sphere

of influence of the hotel, representing of the hotel not, reserves itself the hotel the right to withdraw from the contract without the guest
Claims are entitled.

A cancellation is only in writing form valid. If the guest does not take the ordered room up, without communicating this 7 days in advance, then he remains obligated to the payment of the agreed upon total price, with week final reservations applies 14 days before journey, without it depends on the reason of the prevention. Cancellations and changes of the reservation are only 7 days in advance free of charge, with week final reservations only 14 days before journey free of charge, afterwards 80% of the sum total become due.

With fair dates as well as congress times or Events a change and/or a cancellation is free only 3 weeks before journey. Afterwards 80% are computed and starting from 7 days before planned journey 100% of the sum total.

6. Adhesion

The hotel strives for punctual execution of orders for waking, the timeliness and correctness of transmissions of news and a punctual delivery of consignments of goods of all kinds. Lost-clothings are readdressed only on request, risk and costs of the guest. Otherwise the things are handed over to the local lost property office at expiration of a period for safekeeping of one month under computation of an appropriate fee.

8. General information

An ineffective general trading condition will be replaced immediately by the parties by an effective, which comes to its legal and economic content of the ineffective regulation next. Deviating or special agreements requires writing. This applies also to those for outer ones just in written form.
